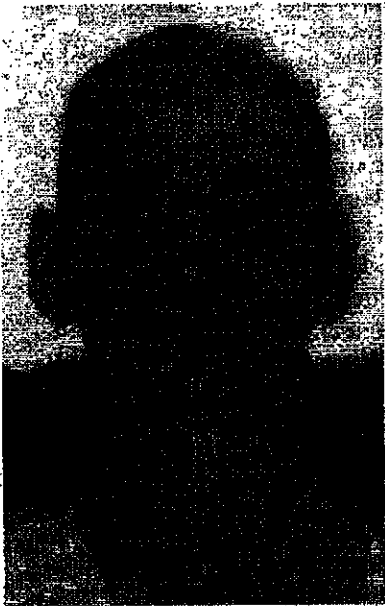


Terry R. Ulrey

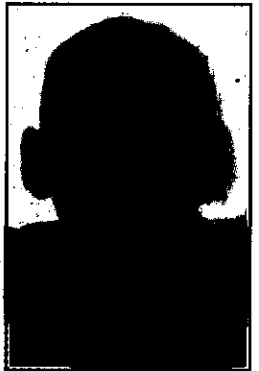
