

## Last Rites Friday For Minnie E. Lang

Funeral services for Minnie Lang were held last Friday morning at ten o'clock at Brauer Funeral Home with the Rev. C.W. Woollard, pastor of Grace Methodist church, officiating. Leo Shuler was organist.

Interment was in I.O.O.F. cemetery with the following serving as pallbearers: C.W. Fowler, E.L. Montgomery, Lynn Montgomery, J.L. McCluskey, Denver Miles and Maynard McLain. Flower attendants were Mrs. Freda Read and Mrs. Maynard McLain.

Minnie Emmeline Lang, daughter of Hugh Thomson Lang and Louie Wilkinson Lang, was born Feb. 11, 1894, in Madison township, near Brooklyn, and died April 5, 1966, in Mercy hospital at Iowa City.

In February of 1902, she moved with her parents into Brooklyn and later the same year moved into the house on Jackson street where she had lived the remainder of her life.

She graduated from Brooklyn High School in 1912 and from the State University of Iowa, Iowa City, in 1917.

In October of 1911, she united with Grace Methodist church under the pastorate of the Rev. F.C. Edwards. She was a charter member of the Philathea Sunday School class, a member of the Grinnell chapter of the Daughters of the American Revolution since 1918 and a member of the Rebekah lodge since 1914. From 1917-1922 she served as secretary of the Brooklyn branch of the American Red Cross.

She is survived by an uncle and an aunt, Dr. H.B. Wilkinson of Santa Monica, Calif. and Mrs. Elizabeth Breniman, of Marengo, and several cousins.

Her parents preceded her in death.

## \$20,000 Bequest For Community Hospital Fund

Grinnell Community Hospital building fund will receive \$20,000, according to terms of the will of the late Minnie Lang of Brooklyn.

Willis D. Shuey of Grinnell, a cousin, is also to share in the estate.

Bequests in the will included the following: University Hospitals at Iowa City, \$80,000; Brooklyn IOOF Lodge, \$10,000 for perpetual maintenance of the IOOF cemetery; Brooklyn Municipal Library, \$5,000; Grace Methodist Church of Brooklyn, \$3,000; Odd Fellows Home at Mason City, \$10,000; Salvation Army at Des Moines, \$1,000.

Several cousins are to receive amounts ranging from \$10,000 to \$500. Residue of estate is to go to Shuey.

## Bequests In Lang Will To Local Organizations

The will of the late Minnie Lang, filed for probate recently, provided substantial bequests for medical research and also left funds for several Brooklyn organizations.

University Hospitals at Iowa City will receive a total of \$80,000 under terms of the will, with \$50,000 going to the eye clinic for glaucoma research, \$20,000 for heart research, and \$10,000 for mental health research.

The Brooklyn I.O.O.F. lodge was willed \$10,000 in trust with income from the fund to be used for perpetual maintenance of the I.O.O.F. cemetery here. The Brooklyn Municipal Library was bequeathed \$5,000 to be used to purchase additional books and for general betterment of the library. Grace Methodist church in Brooklyn was willed \$3,000.

Other major bequests included \$20,000 to the Grinnell Community hospital building fund; \$10,000 to the endowment fund of the Odd Fellows Home at Mason City; and \$1,000 to the Salvation Army in Des Moines.

Several cousins, most of whom reside away from Brooklyn, were willed amounts ranging from \$10,000 down to \$500. Residue of the estate is to go to Willis D. Shuey of Grinnell, a cousin.

Named executor in the will, dated Oct. 27 1964, is Bert R. Gillette, Brooklyn attorney.
