

## **Tragic early** morning fire claims life here Friday


A catastrophic fire claimed the life of a Grinnell resident early Friday morning, Aug. 19. Grinnell police have identified the sole occupant of the residence as Collette Dianne Beach, Law enforcement and state medical examiner officials have declined to provide an identification of the fire victim until additional tests are completed. The Grinnell Police Department, the Grinnell Fire Department and the Iowa State Fire Marshall's Division are all investigating the fire whose cause has not been determined.

"When fire righters lartived," they found the house fully engulfed in flames which took approximately an hour to extinguish. When firefighters entered the home, they found what Grinnell police describe as a "badly burned

body."

An autopsy was performed Saturday, Aug. 20, by the State Medical Examiner's Office which has thus far not identified the victim. Grinnell Police are awaiting the results of additional tests that were performed on the body including toxicology results according to Grinnell Police Sgt. Chris Wray who is handling the investiga-
