The generosity of Grinnellians has furnished and equipped a new apartment for Courtney Heckman, 22, and her family which lost a family member and all its belongings in a tragic fire last weekend. Heckman returned to Grinnell yesterday, Jan. 18, where she is recovering in a new apartment. Friends and family are planning a benefit dinner to raise funds for the family for Jan. 28 and have opened a bank account for those who wish to contrib-

Heckman and her seven-month-old daughter Alyanna Jasmine Chhouy were trapped in a blazing trailer early on the morning of Jan. 14. Grinnell firefighters rescued both from the trailer, and the fire victims were flown to University Hospitals in Iowa City in critical condition. Heckman, improving much more quickly than doctors predicted, was able to return to Grinnell Jan. 18. Alyanna remained on life sup-

port in Iowa City for several days after the fire and died Jan. 17. Funeral arrangements have not yet been made.

Chelsi Rockwell is a family friend of both Heckman and Heckman's fiancé Chollana Chhouy. Yumi's Bakery, co-owned by Chelsi's parents Sam and Heidi Rockwell, became a center for donations as the extent of the fire's damage became known, Heidi says. Clothing, furniture, and everything needed for a new residence for the Heckman family was dropped off at Yumi's over the days since the fire.

Heidi has marveled at the determination of friends of the stricken family who have spent hours sorting donations, doing laundry and working to set up a new apartment into which Heckman could move when released
