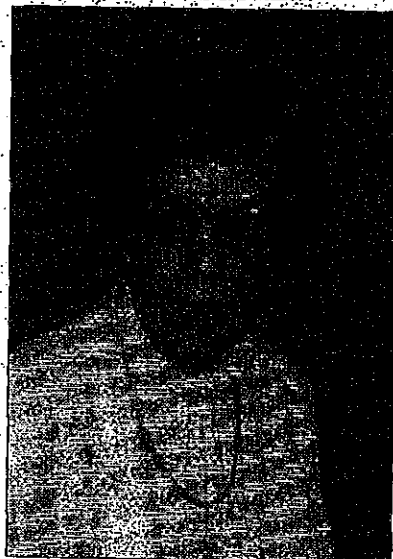


Marie Terlouw, 82, of Grinnell, formerly of Sully, died Wednesday, Nov. 26, 2008, at St. Francis Manor.



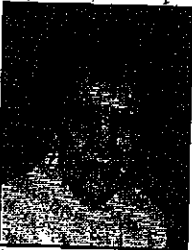
