## Local woman killed in pedestrian accident

A Grinnell woman died Oct. 16 after being struck by a vehicle on Hwy. 6 half a block west of the Grinnell public safety building. The accident victim was Carol Karry, 57, of Grinnell.

At about 10:20 p.m. on Monday, Oct. 16, a 17-year-old juvenile was driving a 2005 Chevrolet Silverado pick-up truck westbound on Hwy. 6. The driver struck a pedestrian, Karry, at 511 Sixth Ave. and Karry was declared dead at the scene. The name of the juvenile driver was not released.
