## Christmas morning fire claims life of one victim

A tragic fire in Grinnell early Christmas morning, Dec. 25, claimed the life of the person living in the home when the fire broke out, Christine E. Carnes, 71, of Grinnell.

At 2:17 a.m. on Friday, Dec. 25, members of the Grinnell Fire Department were dispatched to a fire in a trailer home on First Ave. in Grinnell. Grinnell police officers were also dispatched to the fire scene and arrived before firefighters did.

Upon their arrival, the police officers located a burn victim later identified as Carnes still inside the home. Carnes succumbed to injuries from the fire and was pronounced dead at the fire scene.

The fire was contained to the living room area. The fire is being investigated by the State Fire Marshall's Office, A statement released by Grinnell Fire Chief Dan Sicard says that initial investigation into the cause of the fire reached the preliminary conclusion that "the fire appears to be accidental due to smoking.

The Grinnell Fire Department was assisted at the fire scene by the Grinnell Police Department, Midwest Ambulance, the Poweshiek County Medical Examiner and the State Fire Marshall's Office.
