

Maynard E. Durr 1926–2021





Maynard Durr, 95, passed away Sunday, May 23, at St. Francis Manor in Grinnell after a year's battle of dementia.

Maynard was a lifelong resident of Grinnell and was born in rural Jasper County on January 30, 1926, to Otto and Belle (Thompson) Durr. He was a 1944 Grinnell High School graduate. Two years later, he enlisted in the United States Army, 11th Airborne Division as a paratrooper until 1948. Maynard returned home and was a farmer, self-employed businessperson, and entrepreneur. He worked the family farm west of Grinnell, was the owner/operator of Standard Station by Interstate 80 from 1964-1975, served as a rural mail carrier, built and sold wood-burning furnaces, and built and operated three car washes located in Newton and Grinnell from 1980-1985. After his retirement, Maynard and wife Mary lived at Oakland Acres, where he enjoyed playing golf daily. In 2013, the couple moved in town to Seeland Park to enjoy the community of old and new friends only a few steps away from their front door.

Maynard was blessed with six children from his first marriage with Joan Lemke: Cynthia (Randy) Boulton (Grinnell), Randall (Yvonne) Durr (Omaha, Neb.), Victoria Angell (Creston, Iowa), Theresa (Curt) Wayman (Grinnell), Rebecca (Loren) Alsager (Roland, Iowa), and Sondra (Loren) Burnell (Grinnell), and then in 1983 with the union of marriage to Mary Lea Richards, blessed the family with two more children: Tom Richards (Tanya deceased) (Johnston, Iowa) and Timothy Richards (deceased).

Maynard loved golfing, bowling, fishing, and most of all, filling others' lives with fun and brightening their days with his smile.

Maynard is survived by his wife, Mary, of 38 years; his children; 14 grandchildren, 27 great-grandchildren, and many nieces, nephews, and cousins. He was preceded in death by his parents and his sisters: Golda Mae Sleeuwenhoek, Donna Rae Schulz, Doris Page, and his step-son Timothy Richards.
