John Cleveland Beeler was born July 29, 1884 and died Monday, Jan. 24, 1927, being at the time of his death 42 yrs., 5 months and 24 days of age. He was the fourth son of John S. and Ellen C. Beeler.

Since August 1926 his health has been impaired, so seriously that in December he was taken to the Methodist Hospital in Des Moines and placed under a specialist's care. He spent four weeks there but the desire for his loved ones and home became so intense he was returned home where everything possible was done to save this young life but on Monday evening he went peacefully asleep and at 10:30 his spirit left him for the better land, leaving his home and loved ones to memories and tears.
