Three lives were snuffed out lately, died a short time west of Brooklyn.

fourth person, John M. Budeslich, 31, husband of one of the dead women, was in serious condition following the crash. He was brought to a Grinnell hospital suffering with a broken leg, internal, chest and head injuries. Saturday he was transferred to a Des Moines hospital.

The two children of Mr. and Mrs. Budeslich, Mark 4, and Wendy 18 months, escaped serious injury. The little girl reportedly received a cut on the head and both were suffering

from shock.

The crash, which brought Poweshiek county's 1960 traffic death toll to five, happened at about 4:40 p.m. Since the adult passengers of both cars were all either killed or seriously injured, it was difficult to piece together a picture of what might have happened.

The investigating officers and other workers were on the scene for several hours clearing debris from the highway in order to permit traffic to pass.

First traffic fatality in this county of 1960 was William Buchmeier of Kellogg, who was killed in a car-truck crash just west of Grinnell on March 11th. Joseph Kirsch of Marathon became the second fatality on March 28th when his auto was involved in a crash with a truck at the intersection of highways 6 and 63 east of Grinnell.

## Brooklyn Couple Killed on Friday

BROOKLYN-- Double funeral services were conducted Monday morning at the Catholic church for Mrs. Blanch DePauw, 54, and Edmund DePauw, 72, killed Friday afternoon on Highway 6 in a two-car crash that also took the life of Mrs. Marilyn Budeslich, 30, Des Moines.

A fourth person, John M. Budeslich, 31, husband of the dead woman, was transferred in serious condition to a Des Moines hospital Saturday. Budeslich children, Mark 4, and Wendy 18 months, were not seriously injured.

The Rev. L. H. Mork conducted the service for the DePauw's with burial following in the Brooklyn Calvary cemetery.

Casketbearers were Howie Lang, Glenn Hall, John Henning, Leonard Thys, Perly Newman, William Roth, William Smith, Clarence Possehl, Carl Bruner, James Keller, Edward Hall and Freeman Hall.

Collision occurred about 4:40 p.m. on highway 6 about 2 1/2 miles west of Brooklyn. The three deaths upped Poweshiek county's 1960 traffic toll to five.

Officers at the scene, Patrolmen Gerald Kahler and Paul Gearhart and Deputy Sheriff Ernest Mitchell gave the following report of the crash:

Apparently a car driven by Gene Osborne, Brooklyn, stopped on the highway waiting to make a left-hand-turn into a driveway on the Gordon Osborn farm. Before westbound traffic could clear, two other vehicles also stopped behind the Osborn car.

Officers believe the De Pauw car approached the end of the three-car string and swung out to see if the way was clear to pass. At the

same time the Budeslich car heading West came over the crest of a hill and the two collided.

The DePauw car swung around violently and the Budeslich vehicle careened into the ditch.

Budeslich's had been on a vacation trip and were returning to Des Moines, Mr.
