## Value Estate Of Emmert At \$684,967

Includes 24 Farms In State: 22 Heirs Will

Share In Distribution

Estate of the late Andrew Emmert of Grinnell has been filed in district court at Montezuma, and according to the probate inventory the estate is valued at \$684,967.

Included in the inventory were assets listed at \$398,580 in real estate, and the remainder in stocks, bonds and personal property. There are 24 farms, all located in Iowa.

Twenty-two heirs will share the estate including six children, nine grandchildren and a brother. The children are Mrs. Dorothy Baker of Searsboro, Theodore Emmert of Sully, Lee and Everett Emmert of near Grinnell and Earl and Louis Emmert of Malcom.

A retired contractor, Mr. Emmert died February 22 at the age of 94 years.

## OBITUARY

(Contributed) H-R 2-27-58 Andrew "Andy" Emmert, son of John Valentine and Dorothea Emmert, was born March 20, 1863, in Bedford County, Pennsylvania. When a small child, his family moved to Illinois.

He attended the public schools

of his day.

The family came to Iowa' in 1869, settling in Jasper county. Andy spent his young manhood in Killduff and Newburg communities.

He was united in marriage to Lela Drew, a teacher at Newburg, at Newton, Iowa, and they established their first home in Newburg. Six children were

porn to this home.

Mr. and Mrs. Emmert moved to Lynnville where they were interested in business and farming, and in 1910 they established their home in Kellogg, Iowa. It was here, in 1916, that Mrs. Emmert passed away, a young mother injured in an accident. Andy Emmert kept his family in close contact, and he and four of his sons maintained the home until the children were grown.

In 1918 the Emmert family moved to Newton, Iowa, where they made their home until Andy became interested in contracting and construction. He lived and worked in several central Iowa communities until 1927, when he established his home in Grinnell where he has lived for the past 30 years.

He was active in farming and business until the close of his long life. Illness became a major part of his life in the last year, and he passed away at his home in Grinnell, Saturday, February 22, 1958, almost 95

years of age.
