With the coming of the automobile and the tractor he saw the handwriting on the wall and instead of accepting defeat and bemouning his fate he switched to another line of business, establishing the News Stand and cigar store now owned by Louie Kutish and built it up into a prosperous and profitable concern.

____ Then he decided to locate in Spokane. Wash. He sold his business on Broad street to Mr. Kutish, and although well along in years, went west with all the enthusiasm of a youngster. For many years an expert and enthusiastic bowler, be proceeded in this location to establish one of the finest places of its kind in the west-a modern and attractive home for this well-loved sport. He operated nineteen alleys and employed several men. Less than two years ago he traveled a long distance to personally engage in a bowling contest and came through with flying colors. <u>--</u>0--

About the first of January this year he made a trip to New York to see his daughter Adah and his son Harry. On his way home he stopped off in Minneapolis for a visit with his son Rome. Two days

before he died Rome called him over long distance and Mr. Hopkins talked to him cheerfully and naturally, saying, "I'm all right, son, but I won't be here long, take care of yourself, and good-bye." Dr. Hopkins said his father was game to the end, never a whimper.

David A. Hopkins was born in Bangor, Me., on June 24, 1856, so he would have been, had he lived. seventy-three Jeurs old next June. He passed away at his home in Spokane, Wash., April 22, 1929, His daughter, Mrs. Mah Höpkins Aime of New York, his sons, Harry of New York, Rome of Minneapolis and Dr. Louis Hopkins of Tacoma, Wash. were here Friday to pay their last respects to their father.
