## C. M. Manly Is Victim of Heart Attack + 1.

Was Grinnell's Oldest
Practicing Attorney M71
In Point of Service 1951

Charles Morse Manly of 1118 Third avenue died at approximately 3 o'clock this morning in a local hospital, where he had been taken Sunday afternoon.

Mr. Manly had come downtown as usual Sunday, called for his mail and spent some time at his office.

On returning home he complained of a pain in his chest. A physician was called and he was taken to the haspital. Apparentiv he was resting easily there and there was no causo for alarm, but when a nurse entered his room at about 3:20 a, m. she discovered that he had died in his sleep.

Funeral arrangements are indefinite pending the arrival of two sons, John and Robert from Dallas, Texas, where they are students in Southern Methodist university. Friends are asked to call the Smith funeral home for oarticulars.

Charles M. Manly was born in Grinnell on May 7, 1890, the son of J. C. and Mary Carter Manly, His father served sevoral terms as county supervisor and was one of the potent factors in building up the growing town of Grinnell.

The senior Manly was a pioneer railroad and grain man in lewa and also operated extensively in Grinnell real estate. He served as a member of the city council and the school poard. The town of Manly, north of Mason City, was named in his honor.

attended Grinnell Charies schools, graduating from Grinnell high school with the class of 1909, and graduated in law n 1912 from Drake university. where he was a member of Chi Deita fraternity.

He was married in November, 1923, to Nell Cooper, who survives him with five children. Mary Bea, now Mrs. Jack Letts of Des Moines, John and Robert, students of Southern Methodist university in Dallas, Texas, Charles, Jr., a law student at

From 1912 to 1924, Mr. Manig was a member of the law firm of Beyer and Manly. During World War I he enlisted and served II months in the MTC n María, Texas. He was disharged in 1919.

Since 1924 Mr. Manly has been engaged in his private law practice and in looking after his extensive property interests in Grinnell.

He was a member of the American Legion, Poweshick county and Iowa state bar associations, Elks club, Masons, Royal Arch Masons and the Congregational church.
