

Brooklyn Loses ^{G-4} ¹¹⁻²⁴⁻¹⁹³³ Honored Citizen

Last Friday H. H. Reed died at his home in north Brooklyn following two years of poor health, during which time he had returned to Brooklyn to live after an absence of over thirty years.

Between 1882 and 1900 Mr. Reed was active in the church, social and business life of Brooklyn. Although he spent much time away from Brooklyn in the past thirty years, nevertheless he has always seemed to the older people of the community to belong to Brooklyn and they gladly welcomed him back two years ago to spend the remaining years of his life here.

Although never admitted to the bar, he was closely associated with the lawyers of the county through his work in Judge Scott's office where he studied law and assisted the judge. The group of lawyers with which he worked—although not exactly one of them—are most of them dead, and Mr. Reed's passing breaks another link with the early legal life of Poweshiek county.

Mr. Reed's death is mourned not only by his own family but by a large circle of friends who have long recognized him to be a man of the finest character and one of the real community builders of Brooklyn in the days of his active life here.

Henry Harvey Reed, son of David and Sarah Reed, was born in Delaware county, Indiana, on January 13, 1853, and died at his home in Brooklyn, Ia., on Nov. 17, 1933, aged eighty years, ten months, and four days.

Mr. Reed's parents both died when he was a young boy, and he made his home with friends of the family until he was married to Emma Alice Heath on February 22, 1874. To this union were born nine children, three of whom, Mabel, Carrie Belle, and Lulu, preceded their father in death. Mrs. Reed died on Jan. 12, 1899. On March 8, 1913, Mr. Reed and Mrs. Alnie M. Kirk of Evanston, Ill., were married, and she, together with six children, U. M. Reed, Brooklyn, Ia.; Mrs. T. A. Bailey and Mrs. Ralph G. Hart, Pipestone, Minn.; Mrs. G. A. Sheils, Stillwater, Minn.; Mrs. Bert J. Hull and Miss Mildred Reed, Los Angeles, Cal.; and thirteen grandchildren and four great grandchildren survive.

Funeral services were held in the Methodist church at Brooklyn on Sunday, Nov. 19, conducted by Rev. J. H. Freedline. Music was furnished by Leo Shuler at the organ. Pall bearers were J. F. Lineweaver, J. A. Drake, J. W. Staples, W. K. Karr, Joseph Karr, and C. J. Dunlap. Interment was in the I. O. O. F. cemetery at Brooklyn, Ia., where the Masonic burial service was conducted by Corinthian lodge No. 174 A. F. & A. M., with Mr. Reed's grandson, Harold J. Reed, in charge of the ritualistic service.
