They were members of the Kellogg United Methodist Church and the Kellogg Historical Society. Mr. Sullens was a former Kellogg fire chief and a member of the

Masonic Lodge.

He is survived by one brother, William E. "Mike" Sullens of Gordon, Neb., and was preceded in death by his parents, one sister and three brothers. She is survived by one brother, Charles L. The Jasper County medical examiner has ruled that the deaths of two Kellogg residents were a murder and a sui-

The bodies of Francis Sul-lens, 87, and his wife Alberta, 84, were found Sept. 27 in their home, dead of carbon monoxide poisoning.

Dr. Pat Édwards, the medical examiner, said Francis

Sullens committed suicide but that Alberta Sullens was a homicide victim because she suffered from Alzheimer's dis- 5 ease. The disease, Edwards Y said, made her unable to decide whether she wanted to commit suicide.

The couple's car was running in the basement garage & and caused the carbon monoxide deaths, authorities said.
