## Mrs. Van Tomme Killed In Auto Accident In Iowa County Friday

A Brooklyn woman, Mrs. Clemance VanTomme, 80, died Friday, Dec. 23, about 10:30 p.m. in an Iowa City hospital from injuries she received in a one-car accident in Iowa County. Mrs. VanTomme was a passenger in the car driven by August Cleppe, 80, of Brooklyn.

They were traveling east on highway 6 and attempted to turn north on highway 21 to go to Belle Plaine when lights blinded Mr. Cleppe. He lost control and the car overturned. They were taken to an Iowa City hospital by a Victor ambulance. Mr. Cleppe was treated for lacerations and bruises.

The accident occurred about 5:30 p.m. It was investigated by Highway Patrolmen Timothy Driscoll and

Charles Hooper.
