Growing to manhood in this area, he also attended rural school. In December of 1941 Mr. Weisskopf became a member of the United States Navy and served his country during World War II. Following his discharge in October of 1945 he returned to Iowa where he and his wife May, whom he married in September of that

year in Boston, Mass., established their home in Malcom. To their marriage were born five children - Donna, Daniel, Carol, Phillip and Susan.

Following Mrs. Weisskopf's death in May of 1958, Daniel continued to make Malcom his home where, for over 20 years, he was active in service station management.
